Discussion:

**Councilmember Messick** - Expressed concerns of the rezoning and the purpose of the rezoning of the property, raising the concern that the property is not legally owned, paperwork to complete the legal entity with the Secretary of State is pending and submitted drawings for parking do not show an adequate amount of parking spaces. Councilmember Messick would prefer to table this item until the applicant's paperwork is finalized with the state.

**Mayor Day** states that nothing can be built until the plans are approved. Additionally, this is a civil matter between the buyer and the seller; the city has no involvement with the sale of the property.

**Mr. David Allen** shared that he spoke with the Secretary of State and was informed that it takes up to fifteen days for paperwork to be processed. Additionally, Mr. Allen noted that if the annexation is approved, the rezoning is a natural following, automatically assigning the closest zoning which will be C2 city.

**Councilmember Sartor** expressed concerns that we remain equitable to all businesses coming into the city, raising the question if conducting background checks on potential business is the standard procedure for these types of requests.

**Mr. Clark** added that the city does not know the relationship between potential sellers and buyers. If the annexation and rezoning are approved; and if the sale of the property doesn't happen because of legal issues with the current owner, the potential owner will not sign the contract as the sale is typically contingent on approvals. This is only one step of the process, the applicant will have to adhere to all regulatory codes related to building and go through the necessary code requirements are in place.

**Councilmember Sebo-Hand** - stated that this is a private matter between the seller and the buyer, not the city.

#### Discussion

**Councilmember Sartor** asked what paperwork is pending for this item and if it is required for approval.

**Mayor Day** replied, the ownership of the property.

**Mr. David Allen** states that his approval is based upon meeting the conditions of the zoning code.

**Councilmember Lester** expressed his general concerns of the closeness of the proposed location and the impact it will have on Tara Package sales as well as other businesses in the area selling beer and wine.

**Councilmember Sebo-Hand** clarified that council approved two liquor stores would be allowed, on a main collector street in the city limits, based on population and distance. Regardless as to the location, there will always be competition.

**Councilmember Sartor** stated we must be consistent with our businesses, not consider competition and remain as objective as possible.

**Councilmember Wise** stated competition is the American Way, additionally stating he would continue to shop at Tara Package if another store opens.
